Community Services

Executive Director of Community Services Lisa Jacobs reported to the Board of Education on programs and services offered through the district's Community Services Department, which include the district's preschool and child care services; River Valley Academy alternative high school; Rockford Adult Education; enrichment, recreation and senior citizens activities; facility use; district publications; and events.

2021-22 COVID Response Planning/Procedures

Assistant Superintendents Mike Ramm (Instruction), Korie Wilson-Crawford (Human Resources), Mike Cuneo (Finance), and Executive Director of Community Services Lisa Jacobs reported to the Board of Education on operational and instructional plans for the 2021-22 school year relative to COVID-19 recommendations and requirements.

Dr. Shibler stated that the goal is to keep schools open and operating safely but cautioned that these plans are based on what is known at this time with the understanding the district will adapt based on any future orders or evolution of the pandemic.

In-person instruction will take place unless prohibited by a public health order or when remote instruction is necessary as a mitigation strategy. While face coverings will be recommended for staff and students in the buildings, choice is offered unless a legally-binding public health order goes into effect. Face coverings are federally mandated on school buses. The district will continue with enhanced cleaning of facilities and buses and provide social-emotional support to students. Details will be emailed to parents this week and up-to-date information will be housed on the district website.
