FIRST AMENDMENT TO LEASE AGREEMENT

THIS FIRST AMENDMENT TO LEASE AGREEMENT (the "First Amendment") is entered into as of September 1, 2024 ("Effective Date"), between the CITY OF ROCKFORD, a Michigan municipal corporation, whose address is 7 South Monroe Street, Rockford, Michigan 49341 (the "City"), and ROCKFORD PUBLIC SCHOOLS, a Michigan general powers school district organized and operating under the provisions of the Revised School Code, MCL 380.1 *et seq.*, whose address is 350 North Main Street, Rockford, Michigan 49341 (the "School District") (each individually a "Party" and collectively, the "Parties").

RECITALS

- A. The Parties entered into a Lease (the "Lease"), dated February 1, 2016, wherein the City leased to the School District property located at 250 Sigsbee Avenue SE within the City of Rockford (Tax Parcel No. 41-06-36-282-009) ("Property" or "Parking Lot Property") for use as a surface parking lot.
- B. The Parties desire to amend the Lease by adding to the leased property the athletic field, which is contiguous to the Parking Lot Property and which is located at 220 Monroe Street NE within the City of Rockford (Tax Parcel No. 41-06-36-403-051) ("Athletic Field").
- C. Except as amended by this First Amendment, the remaining terms and conditions of the Lease are unmodified.

NOW THEREFORE, in consideration of the foregoing and the mutual promises and covenants contained herein, the Parties agrees as follows:

- 1. **Purpose.** The City hereby leases to the School District and the School District hereby leases from the City the Athletic Field for fifty (50) years from the Effective Date first written above under the same terms of the Lease, except as more specifically described below.
- 2. Use of Property. The School District's use of the Athletic Field is intended for school-sponsored sports, such as rugby and baseball. The School District's use is intended as exclusive. The School District will not charge users to access the Athletic Field, unless the School District has received the City's prior written consent.
- 3. Improvements. The School District, at its sole expense, may make improvements to the Athletic Field, including but not limited to leveling the ground, re-seeding the grass, and replacing or repairing the existing fencing. The School District will not, however, install or erect any other structures or buildings on the Athletic Field without the City's prior written consent. The District will not cause or allow any lien to be placed upon the Athletic Field and will assume all liability in the event of any such lien. Any improvements that are attached to or underlying the Athletic Field will belong to the City upon expiration of the First Amendment.
- 4. Consideration. Rent will not be required for use of the Athletic Field. Instead, for and in consideration of this First Amendment, the School District will be responsible for

maintaining, mowing, and making improvements to the Athletic Field, which is intended to constitute a fair exchange of value.

- 5. Assumption of Risk. The School District acknowledges that exercise and recreational activity pose inherent risks, including but not limited to bodily injury, illness, paralysis, and death. The School District agrees to assume those risks. If the School District or its students or agents require medical attention during or after using the Athletic Field, the City will not be held responsible for injury or costs. Nothing contained herein is intended to, nor will it, waive the Parties' defense of governmental immunity or other statutory immunities.
- 6. Liability Insurance. The School District will obtain and maintain at all times during the term of this First Amendment a general liability insurance policy, including public liability and property damage, in such form and from such company as is reasonably acceptable to the City covering the negligent acts or omissions of the School District and its board, officers, employees, guests and invitees at the Athletic Field in the amount of at a minimum \$1,000,000 for bodily injury and at a minimum \$1,000,000 for property damage, or at a minimum in a combined single limit of \$2,000,000 for each occurrence and in the annual aggregate. Such policy will name the City as an additional insured and provide that it will not be canceled or materially changed or altered without first giving the City thirty (30) days' written notice thereof. The School District will, upon request, provide the City with a copy of the policy or an insurance certificate evidencing such insurance coverage during the term of this First Amendment.
- 7. Right of First Refusal. If the City, at any time during the this First Amendment, receives a bona fide offer from a third party to purchase any of the Athletic Field, the City will send the School District a copy of that offer and notify the District in writing whether it intends to accept same. If the City intends to accept that offer, the District will have the right for ninety (90) calendar days after the date of that notice to match the terms of the offer and the District, if interested in matching, will exercise that right in writing. If the School District does not elect to match the offer within that time, then the City may sell the Athletic Field to the third-party offeror. In such event, this First Amendment will terminate at the end of the ninety (90) calendar days and the District will surrender and discontinue use of the Athletic Field at that time. Even if the School District does not exercise its right of first refusal, however, the City will require that the third party assume, maintain, and honor the balance of this First Amendment's duration given the bond proceeds used to finance the improvements thereon.
- **8. Recording.** Upon either Party's request, the Parties will execute and record a Memorandum of this Agreement with the Kent County Register of Deeds, the recording costs of which will be paid by the School District.

9. Miscellaneous.

(a) Except as specifically modified above by this First Amendment, the Lease remains unmodified by the Parties. The Lease shall continue in full force and effect and is hereby ratified and affirmed by this First Amendment.

- (b) This First Amendment is binding upon and will inure to the benefit of the Parties and their respective permitted successors and assigns.
- (c) In the event of any conflict between the terms of this First Amendment and the terms of the original Lease, the terms of this First Amendment will govern and control.
- (d) This First Amendment may be executed in separate counterparts, including facsimile copies, each of which will be deemed an original, all of which counterparts will constitute one in the same First Amendment.



A secondary math coach was added to support teachers this year on lesson design implementation, coaching cycles, unpacking standards and professional learning.




